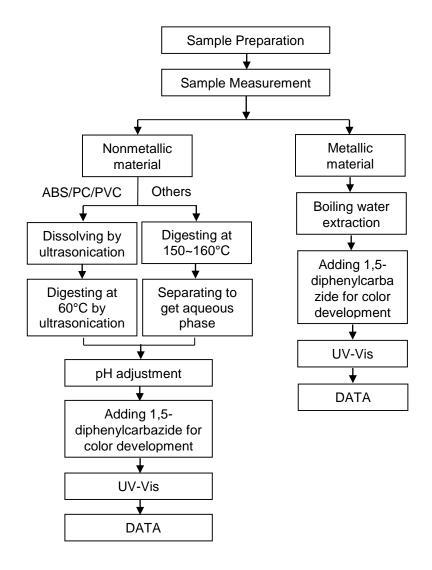

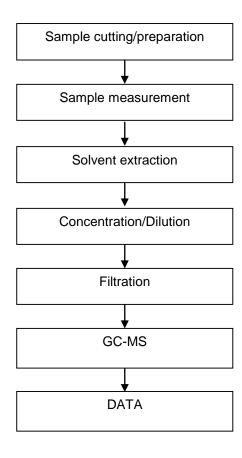

Phthalates Testing Flow Chart





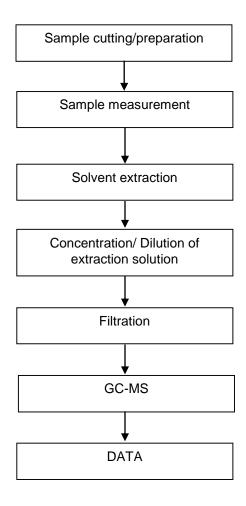

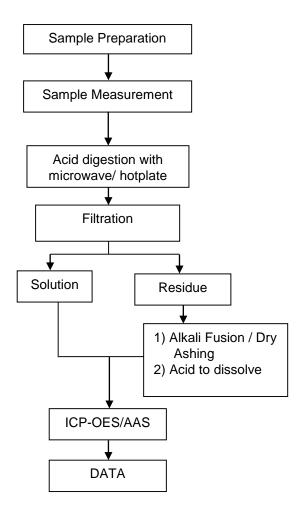

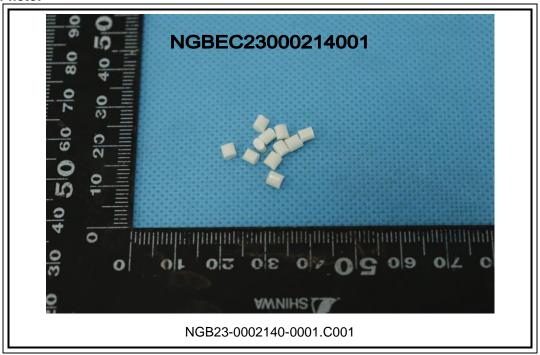
